LOCATION AND DESCRIPTION

Monterey Hills Elementary School, 1624 Via Del Rey, South Pasadena, CA 91030 – Project will require removal and disposal of existing Asphalt and organics. The project will include the installation of EasyTurf Nutmeg Premium and 2.125" Playground Pad; 135 LF of curbing and a perimeter of composite nailer board. The project will also include the Installation of Little Tikes Commercial Play Equipment.

SITE PREPARATION & INSTALLATION

1. Removal and disposal of existing asphalt and organics
2. Installation of concrete curb.
3. Installation of Selected Little Tikes Play Unit.
4. Install composite nailer board along perimeter for secure turf installation.
5. Installation of aggregate base that is compacted to 90%.
6. Installation of Play Pad
7. Installation of **EasyTurf Nutmeg Premium** synthetic turf.
8. Supply and install sand infill.
9. Clean area and complete final inspection.
10. **8 Year non-prorated Warranty.**
11. **8 Year pre-paid non-prorated 3rd Party Insured Warranty, 0 deductible, no limit on claims.**
