

**RESOLUTION NO. 2016-2017-15**

**RESOLUTION OF THE BOARD OF EDUCATION OF THE  
SOUTH PASADENA UNIFIED SCHOOL DISTRICT  
CERTIFYING TO THE BOARD OF SUPERVISORS OF LOS  
ANGELES COUNTY ALL PROCEEDINGS IN THE  
NOVEMBER 8, 2016 GENERAL OBLIGATION BOND  
ELECTION FOR MEASURE SP**

WHEREAS, the Board of Education of the South Pasadena Unified School District (the “District”) previously adopted Resolution No. 2016-17-01 requesting the Los Angeles County Registrar of Voters (the “Registrar”) to call an election to be held on November 8, 2016 on a measure to authorize the issuance of \$98,000,000 of general obligation bonds (the “Bond Election”) by the District; and

WHEREAS, the Resolution No. 2016-17-01 calling the election was duly delivered to the Registrar; and

WHEREAS, notice of the Bond Election was duly given as required by law; and

WHEREAS, on November 8, 2016, the Bond Election was duly held and conducted for the purpose of voting a measure for the issuance of general obligation bonds of the District in the amount of \$98,000,000 designated on the ballot as Measure SP (“Bond Measure”); and

WHEREAS, the Board of Education of the District has received from the Registrar the Certificate of the Canvass of the Election Returns related to the Bond Election, a copy of which is attached hereto as Exhibit “A” (the “Canvass”); and

WHEREAS, as set forth in the Canvass, more than fifty-five percent of the votes cast on Bond Measure were in favor of issuing general obligation bonds as described in the Bond Measure.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE SOUTH PASADENA UNIFIED SCHOOL DISTRICT, LOS ANGELES COUNTY, CALIFORNIA, AS FOLLOWS:**

**SECTION 1.** That entry be made upon the minutes of the meeting at which this Resolution is adopted that the Bond Measure has been approved by more than fifty-five percent of the votes cast at the Bond Election.

**SECTION 2.** That all proceedings of the District in connection with the Bond Election have been accomplished according to law.

**SECTION 3.** That the Clerk of the Board of Education is hereby requested to deliver a copy of this Resolution to the Los Angeles County Superintendent of Schools and the Clerk of the Board of Supervisors of Los Angeles County.

**SECTION 4.** This Resolution shall take effect immediately upon its passage.
